Having graduated with honours in Economics and Commerce at the University of Turin, he is a Chartered Accountant and Auditor, registered in the respective registers. After a two-year research internship at the Faculty of Economics of the University of Turin, he pursued his professional career for more than 30 years, first in the Deloitte & Touche network (formerly Arthur Andersen) holding positions of increasing importance.

Subsequently, he decided to set up an independent organisation where he could carry out his professional activity with the utmost attention to ethics and code of conduct, establishing a professional firm of which he is Equity Partner and which currently employs over 30 people.

He has been involved in developing national and international auditing methodologies and accounting standards, including as a member of the boards of directors and control bodies of multinational companies operating in various industrial and commercial sectors, listed on the Italian stock exchange and on foreign stock exchanges.

He advises on corporate reorganisation and restructuring transactions, as well as financial and asset finance transactions.

He has carried out due diligence assignments for acquisition transactions and the provision of fairness opinions for capital increases and corporate mergers.

He provides corporate, business valuation, M&A and tax advisory services to Italian and multinational companies and groups, particularly regarding the adoption of correct transfer pricing policies.

He is a member of the "Holding" Study Group and the "Arbitration" Study Group of the Order of Chartered Accountants and Accounting Experts of Turin.

He is also a member of Nedcommunity, the first Italian association of non-executive and independent directors, committed to good corporate governance since 2004.

Formerly a member of the Corporate Governance & Compliance Committee of ANDAF, he examines corporate governance issues, highlighting their organisational and technical implications.



In his work, he has gained consolidated experience of relations with Supervisory Authorities and IGOs (Bank of Italy, Consob, US SEC, EU, OECD).
