

## Call Global Issues - Integrating Different Perspectives on Social Inequality

As part of the Global Issues – Integrating Different Perspectives on Social Inequality call, promoted by the Compagnia di San Paolo Foundation, Volkswagen Stiftung, Novo Nordisk Fonden and Riksbankens Jubileumsfond, a total of 252 pre-proposals were received. Based on the outcome of the two-phase evaluation process carried out by an international review panel, 8 projects were considered eligible for funding, for a total amount of €11,590,900.
